UCSRB coordinates implementation of the Upper Columbia Spring Chinook Salmon and Steelhead Recovery Plan for the purpose of restoring and preserving habitat for salmonids listed under the Endangered Species Act in the upper portion of the Columbia River. This work is accomplished through: 1) partners implementing restoration and protection projects in the Upper Columbia region (with direct and leveraged funding in 2020 that resulted in 40 projects); 2) science and policy initiatives that inform federal, state, local, and tribal agency partners, as well as 18 NGO and agency project sponsors to assist with project planning, prioritization, and development; and 3) facilitation of the North Central Washington Forest Health Collaborative, an effort of 23 diverse forest stakeholders working with the U.S. Forest Service (USFS) to accelerate aquatic restoration on regional USFS-managed lands. In 2019, UCSRB planned and prepared for its biennial science conference, which was hosted in 2020 with over 200 attendees from across the Pacific Northwest. Scientists, policy makers, and practitioners representing nonprofit organizations, state, local, and federal agencies, tribes, and elected officials participate in this conference focused on shared learning of the current state of science and understanding in salmon recovery.
